# Vendor Rules and Liability Waiver

- The Great Rescue Caper is a rain or shine adoption event. No refunds due to weather or acts of nature. No refunds for participant's cancellation.
- All spaces are 10x10 unless otherwise specified.
- All animals brought by vendors must be fully vetted (Spayed/Neutered, Vaccinated, Heartworm/Flea Preventative)
- Booth rental DOES NOT include table(s), chairs, signage, or electricity.
- Booth placement is at the discretion of the event management. You will be notified of your booth placement with the vendor package email.
- Booths must be manned at all times during the event.
- Vendors are responsible for decorating their booth (our theme is superheroes! Have fun with it!)
- All booths must have an adult 18 years or older.
- All vendors must collect and report sales tax from the event in accordance to Texas State law.
- Vendor parking information will be provided in the Vendor Acceptance Packet, which will be emailed one week prior to the event.
- No vehicles allowed in the event area.
- Vendors must set up by 9:45 am. If you believe you will need more than 2 hours for set up please let us know.
- Vendor setup will begin at 8:00 a.m. Saturday, April 14.
- Vendors are responsible for the cleanup of the trash in around their booth. Trash receptacles will be located throughout the event.
- Vendors must adhere to all statutes, ordinances, rules, regulations and directions issued by any authorized authority of the federal, state, or city government.
- Event management reserves the right to remove from the festival any vendor displaying behavior or products which is in the opinion of the management objectionable.
- Event management reserves the right to decline a vendor's application if they deem the product or service not suitable for The Great Rescue Caper Adopt-A-Thon.
- Property brought onto the event premises by any vendor is at the vendor's sole risk.
- Vendor retains liability and assumes all risks of loss and/or damage on site or in connection with transportation, display, storage, and sale of merchandise.
- Mixing of chemicals or possession of explosive materials is not allowed at any time.

## Agreement of Liability Waiver
